

Timber from Russia and Belarus considered 'conflict timber' (4 March 2022)

Due to the ongoing military invasion and humanitarian crisis in Ukraine, the Board of PEFC International clarified on March 4 2022 that all timber originating from Russia and Belarus is 'conflict timber' and therefore cannot currently be used in PEFC-certified products.

PEFC suspends PEFC Russia (11 August 2022) and PEFC Belarus (14 April 2022)

PEFC Russia and PEFC Belarus have been suspended by the PEFC International Board. Certificates issued against the National Forest Certification System of Belarus (both SFM and CoC) are no longer PEFC recognised as of 18 April 2022. Certificates issued against the Russian National Voluntary Forest Certification System (FCR) are no longer PEFC recognised as of 11 August 2022. This applies to both forest management and chain of custody certificates. Certified organisations are therefore prohibited from using PEFC claims and the PEFC label and cannot sell material as PEFC certified.
