

Timber from Russia and Belarus considered 'conflict timber' (4 March 2022)

Due to the ongoing military invasion and humanitarian crisis in Ukraine, the Board of PEFC International clarified on March 4 2022 that all timber originating from Russia and Belarus is 'conflict timber' and therefore cannot currently be used in PEFC-certified products.

Belarus has been suspended by the PEFC International Board, following a request by PEFC Belarus. Certificates issued against the National Forest Certification System of Belarus (both SFM and CoC) are therefore no longer PEFC recognised as of 18 April 2022.
